Each year in early February, schools begin a budget and staffing preparation for the upcoming school year. Integral to the process is the re-registration of existing students. Before admitting new students, all existing students are given priority to re-register. The **deadline for re-registration is February 23rd, 2024.** Until that date, there is no fee to re-register and placement can be secured for the 2024/2025 school year. Parents re-registering their children after February 23rd are subject to a \$50.00 application fee and their acceptance cannot be guaranteed.

Family Payment Schedule Information

Family Payment Schedules will be available for signature after **April 8th**, **2024**. These <u>must</u> be signed by **April 29th**, **2024**. Families who have not returned a signed Family Payment Schedule will be removed from school enrolment and considered <u>not registered</u>.

Families must submit a complete application with supporting documents (2023 Tax return) to your school's principal. Application forms are available at your school office or on the School and ICS website. The deadline for applying for financial assistance is <u>no later than</u> May 1st, 2024. Applications are to be submitted to the principal of your school. Families with children at multiple schools are to submit to St. Andrew's High School.

Although it is ideal that all applications be received by the deadline, we understand that a family's financial situation may change at any time throughout the year. Applications may still be considered after the deadline should this occur.
